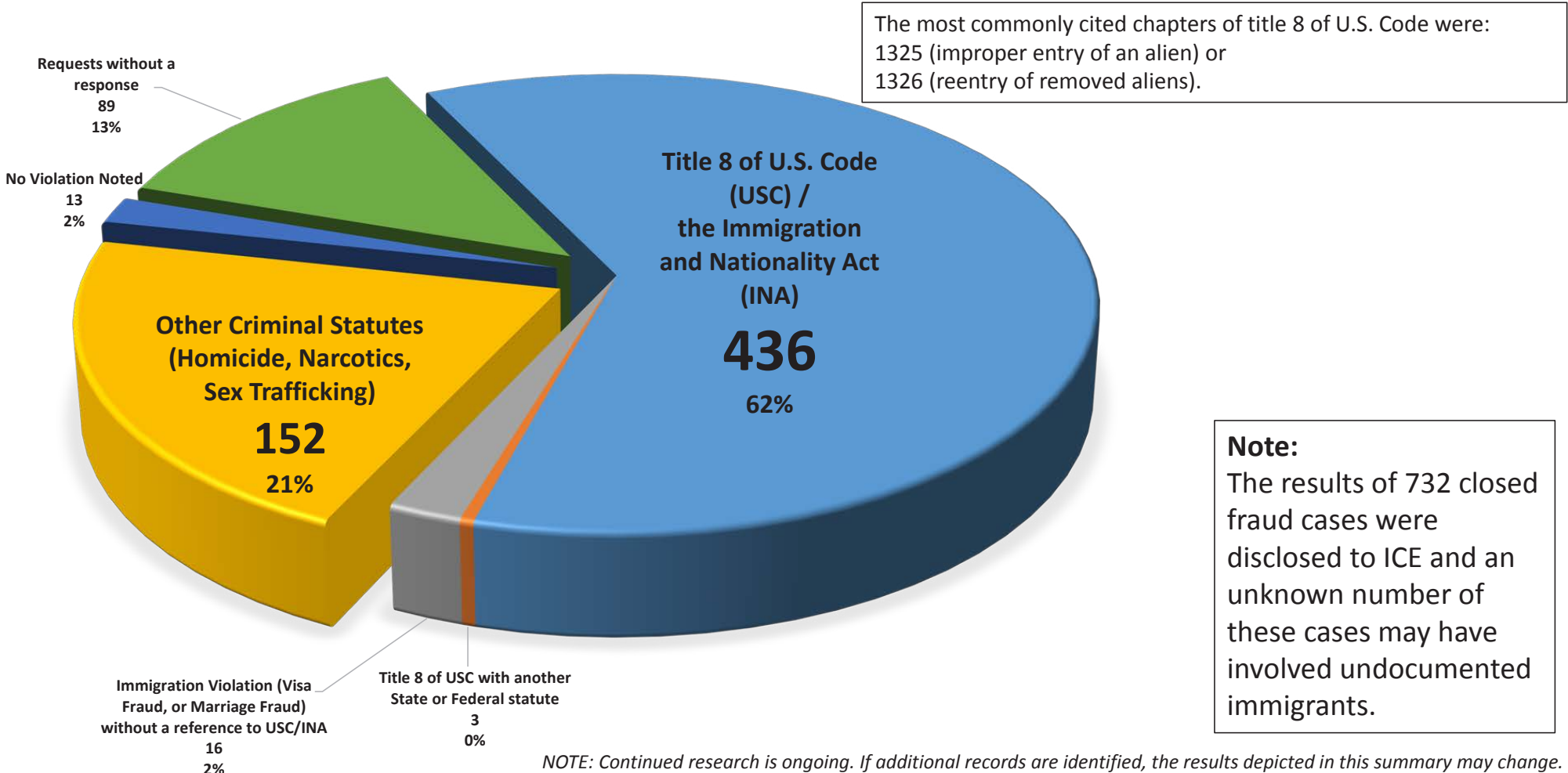
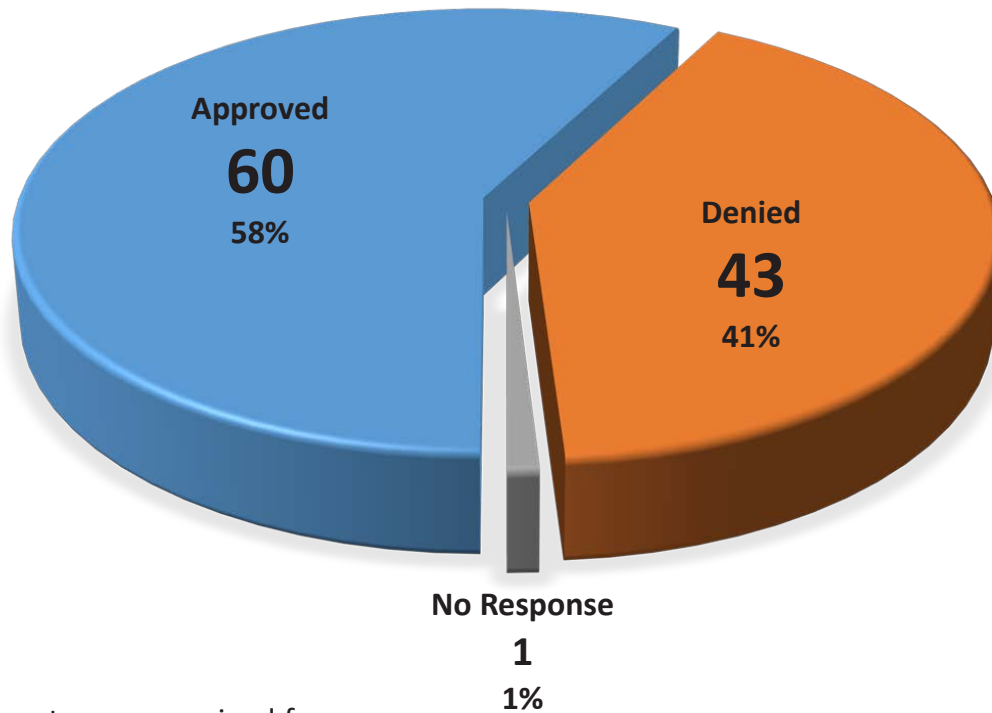

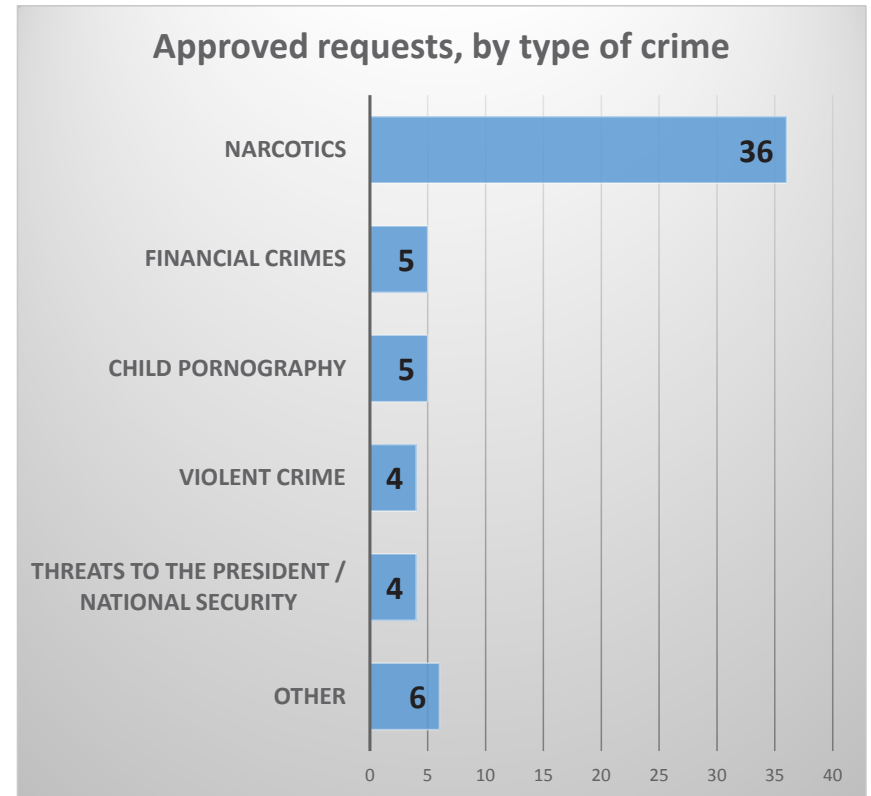


104 potentially immigration-related requests have been forwarded to the Governor's Office for review since January 10, 2018
