

Seller (Current Registered Owner) Read all information provided below

- 1) **COMPLETELY FILL OUT REPORT OF SALE BELOW (Incomplete information may void your report of sale.)**
- 2) Detach bottom section and make a copy for your records. (IMPORTANT: A seller's report does not transfer ownership.)
- 3) Send to the Department of Licensing at the address shown above.
- 4) The completed form **must** be **received** by the Department of Licensing, **within 5 days** of sale, (excluding Saturdays, Sundays, State and Federal holidays).
- 5) Sign "Release of Interest" on Certificate of Ownership (Title). The buyer must present the signed title at a vessel licensing office when transferring ownership

RCW 88.02.070 requires the registered owner of a vessel to notify the Department of Licensing in writing, on the appropriate form, of the sale or transfer of the vessel.

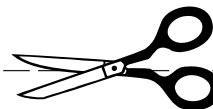
A registered owner selling or transferring interest in a vessel SHALL BE RELIEVED OF PERSONAL LIABILITY FOR AN ABANDONED/DERELICT VESSEL, and shall not be deemed to be the owner of the vessel SO AS TO BE SUBJECT TO CIVIL OR CRIMINAL LIABILITY for the operation of the vessel thereafter by another person WHEN:
 1) He/she has made PROPER ENDORSEMENT AND DELIVERY of the Certificates of Ownership and Registration to the purchaser/transferee 2) He/she has DELIVERED TO THE DEPARTMENT WITHIN FIVE DAYS from the date of delivery, (excluding Saturdays, Sundays, State and Federal holidays) a "Report of Sale," indicating THE DATE OF DELIVERY, THE NAME AND ADDRESS OF THE NEW OWNER or transferee, and A DESCRIPTION of the vessel; or PROPER DOCUMENTS for registration of the vessel pursuant to the sale or transfer.

IMPORTANT: If a Report of Sale has not been submitted to the department and the new owner has not applied for Certificate of Ownership and the vessel is later abandoned, the registered owner will be presumed to have abandoned the vessel. (RCW 88.02.070).

PENALTY FEE FOR LATE TRANSFER

Transfer of ownership is required when there is a change in ownership. This includes, but is not limited to, adding or deleting registered owner(s), when the vessel is sold, traded or given as a gift. The transferee/buyer is required to transfer the certificate of ownership within 15 calendar days, from date of delivery. This can be done using the Application for Certificate of Ownership, TD-420-289, which may be obtained from the DOL Website at: www.dol.wa.gov or from your nearest Vessel Licensing Office. Failure to transfer ownership may result in monetary penalty. (RCW 88.02.070)
