- **Ganacsi ka Baxsan Gobalka Washington**—Lifaaqa soo raaci nuqulka saxda ah ee mid kamid ah dukumiintiyada soo socda:
  - Ruqsadaada hadda ee ganacsiga, ama;
  - Waraaq uu saxiixay mulkiilaha ama wakiilka sharciga ah oo muujinaysa inaad tahay wakaalad. Waraaqdaan waa in lagu qoraa Lambarka Aqoonsiga Loo Shaqeyaha ee Federaalka (Federal Employer Identification Number, EIN) ama Lambarka Federaalka ee Aqoonsiga Canshuurta (Federal Tax Identification Number, TIN)

  - Nuquladaada wada shaqaynta, oo uu buuxshay Xoghayaha Gobalku, ama;
  - Aqoonsigaaga Canshuur Dhaafka, (501)(c)(3), oo kasoo baxay Adeegga Dakhliga Gudaha
- **Wakaalada dhoofinta/rakaabka**—Soo dir nuqullada saxda ah ee:
  - Ruqsadaada hadda ee ganacsiga
  - Biilka iibka
  - Dukumiinti saxiixan oo kuu fasaxaaya inaad matasho iibsadaha
- **Qareenka**—Lifaaqa soo raaci nuqulka saxda ah ee kaarkaaga hadda ee baarka, ama cadaynta aqoonsigaaga hadda/shaqaynaysa ee baarka ee gobalkaaga.
