Instructions

Use this application to obtain a fuel tax refund permit account. You must have a permit account to claim a refund of Washington State fuel tax paid for fuel used off-road or in a tax-exempt manner. For definitions of off-road use and exemptions, see RCW 82.38 for special and motor fuel; RCW 82.42 for aircraft fuel.

Definitions

- **Motor Fuel (MF):** Gasoline, ethanol, and any other gas or liquid used to propel motor vehicles or motorboats.
- **Special Fuel (SF):** Diesel, biodiesel, and any other gas or liquid used to propel motor vehicles, except those defined as motor vehicle fuel. Dyed special fuel is not refundable.
- **Aircraft Fuel:** Jet fuel (JET), aviation gasoline (AV), and any other inflammable liquid used to propel aircraft.

Supporting documents required

- **Farming:** If you are exempt from paying sales tax, include a copy of your Department of Revenue Farmer's Certificate for Wholesale Purchases and Sales Tax Exemption.
- **Transportation services for persons with special transportation needs:** Submit a copy of your registration with the Washington Utilities Transportation Commission (WUTC).
- **Commercial air carrier:** Submit the following:
 - a copy of your Certificate of Public Convenience and Necessity issued under section 121 of the Federal Aviation Act;
 - documentation that you operate at least fifteen round trips per week between two or more points; and
 - copies of published flight schedules showing times, days of the week, and points between operations.

After your application has been processed:

- We will send you a claim form.
- You must claim *at least 41* gallons of refundable fuel per claim.
- You may file a claim at any time within 13 months from the date the fuel was purchased.
