Transcript of public hearing on rulemaking for WAC 308-56A-210 and WAC 308-93-440

Ellis Starrett (00:02):

Good morning. This is a public hearing for the ownership and doubt rulemaking with the Washington State Department of Licensing. My name is Ellis Starrett and I'm the agency rules coordinator. I'm going to introduce one of our program staff who's going to give a little bit of background information about this rulemaking. Go ahead Chante.

Chante Vernie (00:20):

Thank you, Ellis. Good morning and thank you for joining us. My name is Chante Vernie and I am the driver and vehicle records assistant administrator. I'm here to provide an update on a proposed change to the ownership in doubt process. Previously, customers were required to send a certified letter to the registered and legal owners of a vehicle or vessel as part of the process. The purpose was to request a release of interest from those prior owners. Through recent rulemaking, we're proposing updates to WAC 308-56A-210 and WAC 308-93-440. These changes will clarify that customers will no longer be required to seek releases of interest before entering ownership in doubt. This update also brings our rules in line with RCW 46.12.635, which protects the names and addresses of vehicle and vessel owners. Since customers often can't access that information, this change will use an [inaudible 00:01:25] while also maintaining privacy protections. Thank you and I will give this, or pass this off to the legislative policy team.

Ellis Starrett (01:35):

Thank you. So I am about to start administering the public hearing. I'm going to read through our public hearing script. Good morning. This is a public hearing before the Washington State Department of Licensing being held to elicit public testimony, both oral and written, with regard to proposed rules amending WAC 308-56A-210 and WAC 308-93-440: ownership and doubt.
