Good morning. I am Denise Stephens. I'm the Vice Chair for the Real Estate Appraiser Commission. Chair Biethan is traveling so I will be facilitating this meeting. ACAL has done a great job at advocating for the industry regarding the topic. We would like to thank ACAL and suspend the subcommittee and maybe look back at it for 2026. That's something we have to vote on and since we cannot vote on it, we will move that one to October also.

Yes. I thought that in our last meeting we had taken action to go ahead and no longer have this committee.

Yep. So the licensing and complaint data was provided in the packet and as you know, we will be moving to an annual report on this data starting in 2026. Now I'll go ahead and move on to the board's commission and outreach report. The housing market report has been, the link has been included in your packets. I would really encourage you to go to that link just to see all of the information that the Washington Center for Real Estate Research has compiled. They have census data, housing market data, and reports even about housing rentals and sales.
