Transcript of public hearing for rulemaking activity for Chapter 308-108 WAC

Ellis Starrett (00:03):

Good morning. This is a public hearing before the Washington State Department of Licensing, being held to elicit public testimony, both oral and written, with regard to proposed rules amending Chapter 308-108 WAC.

The proposed rules create a new chapter under WAC 308-101 to define business rules, guidelines, and the process for conducting administrative reviews of the petitioner's CDL disqualifications based on an adverse decision on the admin per se implied consent hearing per RCW 46.20.308.

This hearing is being held via Zoom and in-person at 1125 Washington Street Southeast, Olympia, Washington. This hearing is taking place at 10:00 AM on October 31st, 2023.
