#### Purpose

In the 2023-2025 transportation budget (House Bill 1125, Section 208), the Department of Licensing (DOL) received funding to pilot a program bringing driver licensing services to underrepresented and rural communities around Washington. Funding for the pilot program ends in June 2025.

The proviso directed DOL to prepare a report by December 1, 2024, detailing locations served, the number and type of credentials issued, and other outcome measures. The proviso also sought analysis of whether flexible mobile licensing services can address service gaps in areas without traditional driver licensing offices.

This report covers DOL2Go activities and transactions from July 1, 2023 to September 30, 2024.

### Planning for DOL2Go Mobile Licensing Unit

Our work providing DOL services onsite to those living unsheltered at Camp Hope in Spokane in the fall of 2022 helped to inform staff and equipment needs when developing the DOL2Go mobile driver licensing pilot. The appropriated funding covered one six-person team working full-time. To most effectively serve the entire state, chosen applicants were existing, seasoned DOL employees seeking to be part of the DOL2Go team, and their positions were backfilled with non-permanent employees. The positions were placed in key regional areas and in high-service areas. This way, employees are available for events while also able to receive training on changes affecting their work, maintain their skills by performing all transactions, and support employees and customers in their area.

During the planning period, DOL sought input from communities across Washington by surveying lead organizations in every county. Survey results showed Chelan, Clallam, Grant, Grays Harbor, King, Kitsap, Kittitas, Klickitat, Pacific, Pierce, Skagit, Snohomish, Stevens, Thurston, and Whatcom counties had high interest in mobile licensing services. Additionally, these counties provided information on specific community groups that might benefit from mobile DOL services.

When DOL2Go officially launched in July 2023, DOL published an informational webpage and process for requesting mobile licensing services. DOL shared DOL2Go information with government and community partners who directly support individuals who are unsheltered, non-English speaking, refugees, asylees, veterans, and affected by other socioeconomic barriers.

#### DOL2Go Pilot Overview

Requests for DOL2Go services began slowly in July 2023 with the first event occurring in August 2023. Community awareness about our mobile licensing team was enhanced through our partnership with the Washington State Department of Health (DOH) and the Department of Social and Health Services (DSHS), who often served alongside DOL2Go at coordinated events. This partnership has proven to be an efficient way of assisting customers, particularly those most in need. Having DOH in the same space allows customers needing a birth certificate easy access to this critical document. With DSHS at the same event, customers who qualify for a low-cost ID card can get the DSHS-issued voucher and apply for benefits in one location.




Figure 1. DOL2Go customers served between July 1, 2023 and September 30, 2024

DOL further built awareness of mobile licensing services by advertising upcoming events through paid social media posts in targeted geographic areas, and by posting the schedule and locations of events on the agency website. Figure 1 shows the growth of customers served during the first 15 months of the DOL2Go pilot.

In DOL's original DOL2Go proposal to the legislature, based on our six-week experience at Camp Hope, we assumed a mobile unit could attend 30 community events each year and issue 1,890 credentials. After the team began to visit communities around the state, they refined their processes through lessons learned and community feedback following each event. This quality improvement practice continues. With more experience behind them, the DOL2Go team set a new goal for 2024 of 72 events. This goal ensured staff had sufficient time to complete planning/back-end activities, set up events, and travel to and from locations. As of September 30, the team attended 83 events in 2024.

Between July 1, 2023, and September 30, 2024, DOL2Go attended 99 community events helping 4,747 customers and issuing 3,304 driver licenses and ID cards. Multilingual DOL2Go team members provided bilingual language services at more than

half of the events. Table 1 below displays the types of credentials and numbers issued, and the number of customers served in an alternate language.

DOL2Go assisted people across Washington:

- Experiencing homelessness.
- Living in rural communities.
- · Residing in assisted living facilities.
- Who are affiliated with a tribe.
- Who are part of the veteran community.
- Who are in Washington state as refugees.
- Who have worked with their McKinney-Vento Homeless Assistance Act liaison to complete a youth verification packet.
- During emergency response following a natural disaster.
- Who live in communities where a traditional office has closed short-term or permanently.

For western Washington events (and eastern Washington events, if practical), the DOL2Go team travels in a leased custom-wrapped passenger van. The passenger van is for transporting staff and cannot be used for customer transactions. The DOL2Go team serves customers at folding tables in pre-arranged facilities and under tents in parking lots. DOL's Information Technology support staff use a cargo van to transport equipment. They set up the DOL2Go mobile workstations and peripheral equipment to conduct transactions.



DOL2Go provides customers with the same services available at traditional driver licensing offices except for written knowledge tests and driving skills tests. All other services are available:

- Original standard and enhanced credentials (Driver License, Instruction Permit, ID card)
- Original Commercial Driver License, if all requirements are met
- Renewal standard and enhanced credentials (Driver License, Instruction Permit, ID Card, Commercial Driver License)
- Copies of driver records
- Reinstatement letters
- Document review for proof of identity




Figure 2. Types of communities and number of credentials issued between July 1, 2023 – September 30, 2024

The DOL2Go team has focused on expanding its reach to different demographics and communities with barriers to receiving service. Figure 2 below shows the community groups served during the first 15 months of the DOL2Go pilot along with the number of people served and credentials issued in each community. The highest areas of need were individuals experiencing homelessness followed by people living in rural areas without a traditional office nearby. Appendix A provides a list of DOL2Go events from July 1, 2023, through Sept. 30, 2024. The list details the event date, name and location; community group being assisted; and the number of credentials issued, and customers served.

Building on our success, DOL has submitted a budget proposal for the 2025-2027 biennium to continue the DOL2Go mobile unit beyond the pilot and increase the staffing level to meet the demand for mobile licensing services.

### DOL2Go Fills Service Gaps

The Department operates seven part-time traditional driver licensing offices offering limited days and hours of operation, ranging from one day a week to two days a month. Part-time offices are in Coulee Dam, Davenport, Ephrata, Goldendale, Morton, Newport, and Oroville. Scheduling staff for part-time offices is done through rotation from nearby full-time offices. For example, one day each week employees scheduled to work in the part-time Goldendale office travel from the Union Gap driver licensing office. Total lease costs for the seven part-time driver licensing offices exceed \$40,000 annually, with individual leases ranging between \$5,000-\$14,000 each year. DOL's permanent driver licensing offices cost about the same while providing service year-round. DOL's permanent driver licensing office leases range between \$5,000-\$14,000 each year.

Four part-time offices have closed since 2020 when their leases expired with no option for lease extension or new leases in alternate facilities. DOL2Go provided services to three of the communities where part-time offices had closed: Friday Harbor, Forks and Republic. In Friday Harbor, DOL2Go's flexibility has allowed the team to respond to community requests and visit other islands in San Juan County. With no building lease, DOL2Go has added Orcas and Lopez Islands to their schedule. The team visits one of the three islands each month. The team travels quarterly to Forks and Republic – other rural communities with former part-time offices. The team holds events in grange halls, community buildings, and libraries.




Figure 3. Washington resident drive time to nearest driver licensing office

DOL2Go mobile licensing services are particularly important for people with limited transportation options who face challenges traveling long distances. More than 259,000 Washingtonians live in a community located farther than a 60-minute drive from the nearest driver licensing office. By bringing these services directly to rural communities, the DOL is making it more convenient for customers to engage with us and demonstrating our commitment to equitable service for all residents. Figure 3 displays the drive time for Washington residents to reach their nearest driver licensing office. The red dots are traditional driver licensing offices.

## **Washington Resident Drive Time to Nearest Driver Licensing Office**

The need for traditional driver licensing offices, part-time and full-time, are continually assessed considering population shifts, customer habits, lease availability and travel costs. DOL2Go has proven to be an effective strategy to fill service gaps.



### **Event Highlights**

The DOL2Go team bundled up and joined REACH, an outreach group assisting people experiencing homelessness, for a pop-up event in the International District of Seattle, Dec. 27, 2023. One volunteer said, "Within the few of hours that we were on site, we assisted our local neighbors either unhoused, temporarily housed or somewhere within the process of getting settled into their new housing. It was really encouraging to learn that some of those that were unhoused in our previous visits have now established permanent housing."

The DOL2Go team attended the Spokane Community Court resource fair in downtown Spokane, Dec. 13, 2023. Most customers were living unsheltered in the downtown area and were happy our team traveled to them for DOL services. The Spokane Community Court, a program of Spokane Municipal Court, relies on community partnerships to improve outcomes for participants, lower recidivism and provide a safe, more secure and healthier community.





DOL2Go spent two days serving the community of Forks and the Makah Tribe, June 26-27, 2024. The Makah Tribal Outreach Coordinator helped to promote the event and arrange space in the community gym in Neah Bay. Turnout was greater than anticipated, and the team stayed an hour longer than scheduled to serve everyone. On the second day, the team traveled to the Forks Library which hosted the event for the Forks community.

On May 30, 2024, DOL2Go provided services to residents at the Washington State Soldiers Home in Orting. The grounds have both transitional housing and a nursing home. Many of the veterans housed here have mobility difficulties and have a hard time getting into one of our traditional offices for service.





University of Washington invited DOL2Go to attend their International Student Day event Sept. 18, 2024. Over 100 students signed up to get a Washington ID card so they would no longer need to carry their passport for identification.

#### **Future Vision**

**Permanent Funding Request**: Building on our success, DOL has submitted a budget proposal for the 2025-2027 biennium to continue the DOL2Go mobile unit beyond the pilot and increase the staffing level to meet the demand for mobile licensing services. In the first 15 months, the team turned down 73 events. Appendix B provides a list of events DOL2Go was unable to attend since tracking began in January 2024. With a fully funded proposal, DOL2Go would add a second team and increase service delivery across Washington.

To better simulate a service counter experience, a portion of the requested funding will go toward cameras integrated with mobile workstations. Currently, customer photos are taken with an agency cell phone and uploaded to the customer application record through a manual, time-consuming process. DOL2Go would also begin offering customers attending rural community events the ability to schedule an appointment. Scheduling appointments gives DOL2Go customers the same convenient option as visiting a traditional office and minimizes wait times for all customers, regardless of whether they reserve an appointment or stop by as a drop-in customer.

#### Conclusion

The DOL2Go mobile unit has successfully provided essential services to people with barriers to visiting our traditional offices, supporting their ability to live, work, drive, and

thrive. DOL2Go provided ID cards to people living unsheltered, supporting hundreds of residents' transition into housing; brought services to schools, tribes, veterans, members of the asylee and refugee community, and assisted living centers; and aided in natural disaster response. DOL2Go also traveled to communities where a traditional office had closed short-term or permanently.

In just the first 15 months, DOL2Go attended 99 community events helping over 4,700 customers and issuing more than 3,300 driver licenses and ID cards. Demand for DOL2Go service continues to increase. Currently, the DOL2Go team does not have the capacity to serve 45 percent of the requests it receives to provide mobile licensing services in underserved communities.

Without continued funding, the program will end on June 30, 2025. The DOL2Go program has proven to be a valuable resource for Washington residents, and with continued support, the program can further enhance its reach and impact.
