This is a public hearing before the Washington State Department of Licensing being held to elicit public testimony, both oral and written, with regard to proposed rules amending WAC 308-100-005, WAC 308-100-036, WAC 308-108-020, WAC 308-108-140, WAC 308-109-010, and adding a new section in chapter 308-109 WAC.

These proposed rules will outline the requirements for motorcycle safety, commercial driver's license and driver training schools to submit information to the department, per SB 5583, passed during the 2023 legislative session. All provided information will be used to populate the interactive map displaying on DOLs website.

This hearing is being held via Microsoft Teams and in person at 1125 Washington St. SE Olympia, WA. This hearing is taking place at 9:30 AM on November 26th, 2024. Public notice of this hearing was given by notice number WSR 24-21-148, filed with the Code Revisor's Office on October 22nd, 2024.

This rule is proposed pursuant to the provisions of RCW 46.01.110 and SB 5583.

My name is Ellis Starrett and my title is Rules and Policy Manager. The Director of Licensing has designated me to preside over this hearing.
